SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF RIVER ISLANDS II

RECITALS

- A. Declarant caused that certain Declaration of Covenants, Conditions and River Islands II to be recorded on April 1, 2016, as **Instrument** No. 2016-037364 in the Office of the County Recorder of San Joaquin County, California ("**Declaration**"), which Declaration encumbers the real property in the City of Lathrop, County of San Joaquin County, State of California, more particularly described on Exhibit "A" attached hereto and incorporated herein ("**Property**"). Unless otherwise specified herein, the capitalized terms in this Supplemental Declaration shall have the meanings set forth in the Declaration.
- B. Pursuant to **Section 2.43** of the Declaration, Declarant, without the consent of any Owner, may record a Supplemental Declaration to conform the Declaration to Applicable Laws, Governmental Requirements, or any conditions imposed by any Governmental Agencies.
- C. Declarant desires to record this Supplemental Declaration to conform the Declaration to the requirements of the California Stata Water Resources Control Board and to advise all Owners of the requirements described herein.

NOW, THEREFORE, Declarant declares as set forth below:

1. Riparian Rights. Declarant and Owner hereby acknowledge that the majority of the Property is riparian to the River and the various watercourses surrounding the Property, and further acknowledge that retention of those riparian rights to all portions of the Property is of the utmost importance to the current and future use and development of River Islands. Consequently, Declarant, Owner, and all other parties bound by the Declaration, agree and confirm that it is their intent to convey with each and every portion of the Property, all riparian rights to which that portion of the Property is entitled, and to keep with any portion of the Property not being conveyed any all riparian rights to which Declarant and each

Owner are entitled (collectively, "Riparian Rights"). There is no intention by any of the Owners bound by the Declaration to sever Riparian Rights from any Lot within River Islands. Notwithstanding the above, each of Declarant, Owner, and all other parties bound by the Declaration, agree and confirm that Declarant intends to except and reserve unto Declarant, its successors and assigns, together with the right to grant and transfer all or a portion of the same:

- A. All rights that the transferred Property may have in and to that Water Right License 2637 (Application 5155/Permit 2720) granted by the State Water Resources Control Board and held by Island Reclamation District No. 2062.
- B. The right and power to utilize, convey, remove, treat, and store the water collected pursuant to Riparian Rights, to divert or otherwise utilize such water, rights or interests on the Property or other property, but without, however any right to enter upon the surface of the Property in the exercise of such rights.

Notwithstanding any other provision of the Declaration, any portion of the Property owned by a government entity, including a public school district, and used for governmental purposes shall not be exempt from the provisions of this Supplemental Declaration.

2. <u>Effect of This Supplemental Declaration</u>. This Supplemental Declaration shall not be deemed to affect the Declaration as covenants running with the land or equitable servitudes, all of which shall be uniformly applicable to all portions of the Property, including those portions of the Annexable Property annexed to the Declaration pursuant to a Supplemental Declaration.
